## ARIZONA FIRE & MEDICAL AUTHORITY BOARD OF DIRECTORS RESOLUTION #AF24-0625-1

(FISCAL YEAR 2024-25 BUDGET ADOPTION)

A RESOLUTION OF THE ELECTED OFFICIALS OF ARIZONA FIRE & MEDICAL AUTHORITY ADOPTING AN OPERATING BUDGET FOR FISCAL YEAR 2024-25 IN THE AMOUNT OF \$61,116,432 TO ENCUMBER SUFFICIENT FUNDS TO COVER OUTSTANDING ITEMS (LIABILITIES, PURCHASE ORDERS, INVOICES, ETC.) FROM THE PREVIOUS FISCAL YEAR; AND TO COMMIT ANY REMAINING REVENUES OVER EXPENDITURES TO BE TRANSFERRED TO THE AUTHORITY'S CAPITAL RESERVE FUND IN SUPPORT OF THE CAPITAL IMPROVEMENT PLAN (CIP), THE PENSION LIABILITY RESERVE FUND ACCOUNT OR THE EMPLOYEE BENEFIT LIABILITY ACCOUNT AND A DEBT SERVICE BUDGET FOR FISCAL YEAR 2024-25 IN THE AMOUNT OF \$2,882,093.

**WHEREAS,** Arizona Revised Statutes, Title 48 requires the Arizona Fire & Medical Authority to adopt an annual operating budget and debt service budget, and;

**WHEREAS,** Arizona Fire & Medical Authority has posted and published its proposed annual operating budget and debt service budget, and;

**WHEREAS,** a Public Hearing was held in compliance with State Law regarding the Proposed Fiscal Year 2024-25 Operating Budget containing funding for continued emergency fire and ambulance services, salaries, wages and benefits for Authority employees, general operating expenditures, continued training expenditures, and debt service;

**NOW, THEREFORE, BE IT RESOLVED** at a duly noticed public meeting of the Governing Board of Arizona Fire & Medical Authority authorized and approved Resolution#AF24-0625-1 to approve and formally adopt the Fiscal Year 2024-25 Annual Budget and Operational Plan in the amount of \$61,116,432 (attached) and Fiscal Year 2024-25 Proposed Bond Debt Service Fund Budget & Operational Plan in the amount of \$2,882,093 (attached); to encumber sufficient funds to cover outstanding items (liabilities, purchase orders, invoices, etc.) from the previous fiscal year; and to commit any remaining revenues over expenditures to be transferred to the Authority's Capital Reserve Fund in support of the Capital Improvement Plan (CIP), its Pension Liability Reserve Fund or its Employee Benefit Liability Account; on Tuesday, June 25, 2024 by a majority of the Governing Board members.
